

Official Rules for First Financial's 2024 Teacher Appreciation Week Giveaway

1. Eligibility:

First Financial of Maryland Federal Credit Union's ("FFFCU") 2024 Teacher Appreciation Week Giveaway (the "Giveaway") is open to anyone who participates in the Instagram campaign and are legal residents in the United States and are at least eighteen (18) years of age at the time of entry. Participants and winners do not need to be current FFFCU members. The Giveaway is subject to all applicable federal, state, local laws, and regulations. Void where prohibited by law. The Giveaway eligibility is determined by FFFCU. Eligibility determination is final.

Employees and Board Members of FFFCU, its subsidiaries, affiliates and advertising, promotion and service agencies are not eligible to participate.

2. Giveaway Period:

The Giveaway Period begins on May 6, 2024, at 12:00:01 p.m. Eastern Daylight Time ("EDT") and ends May 10, 2024, at 11:59:59 p.m. EDT (the "Giveaway Period"). Submissions before or after the Giveaway period will not be counted.

3. How to Nominate:

No purchase is necessary. During the Giveaway Period, followers can nominate an educator for their chance to win in the Giveaway by performing the following actions on FFFCU's Instagram page at <https://www.instagram.com/fffcuofmd/>:

1. **LIKE** the official giveaway post
2. **TAG** an educator in the comments to show your appreciation

Nominators can submit one nominee per comment. Nominators can submit entries for multiple nominees. Nominations should be submitted via Instagram comment.

Incomplete entries or entries which are not in alignment with the requirements will be disqualified. FFFCU is not responsible for problems with the Giveaway entries, including but not limited to entries which are late, incomplete, or cannot be completed due to electronic or technical difficulties, even if the problem is the result of the sole or partial negligence of FFFCU.

You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of FFFCU.

4. Prize and Value:

Five (5) prizes will be awarded to five (5) winners at the conclusion of the Giveaway. One prize per winner and total prize value for each winner is a \$50 Amazon.com Gift Card. The total maximum prize value of all prizes is \$250.00. Gift cards will be awarded in the form of electronic gift card only.

This Giveaway is not sponsored, endorsed, administered by, or associated with Amazon.com, Instagram, or any other social media platform.

5. Winner Notification and Prize Claims:

The five (5) Winners will be selected by a random drawing under the supervision of FFFCU and will be notified within one (1) business day after the conclusion of the Giveaway period through the Instagram Giveaway Post comment stream and a private message. Selection of winners is at FFFCU's sole discretion. Winner selection is final.

Winners must claim their prize within seven (7) calendar days from winner notification. Prizes will be sent electronically directly to the winners. If the prize notification or prize is unclaimed or if potential winner is found to be ineligible or not in compliance with these Official Rules, the prize will be forfeited and an alternate winner may be contacted and awarded the prize. Prizes may not be awarded if not properly claimed. The prize will be awarded within five (5) business days from prize claim.

By acceptance of the prize, winner agrees to the use of their name and/or likeness for advertising and publicity purposes by FFFCU and its agents in all media without compensation, except where prohibited by law.

Prize cannot be redeemed for cash or substituted for another prize and is non-transferable.
