

Official Rules for First Financial's Summer School of Trivia Giveaway

1. Eligibility:

First Financial of Maryland Federal Credit Union's ("FFFCU") Summer School of Trivia Giveaway (the "Giveaway") is open to all FFFCU members in good standing who are legal residents in the United States and are at least eighteen (18) years of age at the time of entry. FFFCU is not responsible for problems with the Giveaway entries, including by not limited to entries which are late, incomplete, or cannot be completed due to electronic or technical difficulties, even if the problem is the result of the sole or partial negligence of FFFCU.

You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of FFFCU.
