

**First Financial of Maryland FCU's
July 2026 Visa Credit Card Sweepstakes**

OFFICIAL RULES

First Financial of Maryland FCU's ("First Financial") July 2026 Visa Credit Card Sweepstakes ("Sweepstakes") is governed by these official rules ("Official Rules"). By participating in the Sweepstakes, each entrant agrees to these Official Rules. Results of the Sweepstakes are final in all respects. The Sweepstakes is subject to all federal, state, and local laws and regulations, and is void in Alaska, Florida, Hawaii, New York, Puerto Rico, Rhode Island, and where otherwise prohibited by law.

An entrant's odds of winning the Sweepstakes depend on the number of eligible entries received. You are not required to purchase any goods or services, pay any money, or submit to any sales promotion effort to enter into the Sweepstakes. Sweepstakes Period: The Sweepstakes starts on July 1, 2026, at 12:00 AM EDT and ends on July 31, 2026, at 11:59 PM EDT ("Sweepstakes Period").

Eligibility: The Sweepstakes is open to all First Financial members in good standing who are legal U.S. residents age 21 or older. Employees of First Financial and/or any affiliated companies, advertising, and promotion agencies are not eligible.

All federal, state, and local laws apply. Void where prohibited. First Financial and its affiliated and parent company, advertising and promotion agencies, are not responsible for printing, distribution or production errors and may rescind, cancel or revoke this Sweepstakes based upon any such error without liability and at their sole discretion.

To Enter: Eligible Card Purchases, as defined below, conducted by a member in good standing will automatically receive one (1) entry for a chance to win one of the Sweepstakes' Weekly Prizes after completing at least five (5) purchase transactions made during the Sweepstakes Period with an Eligible Card. Eligible Entries not selected as a weekly winner will continue to be included for a chance to win in the subsequent weekly drawings.

Eligible members that complete fifteen (15) or more purchase transactions during the Sweepstakes Period with an Eligible Card will automatically receive one (1) entry for a chance to win the Sweepstakes' Grand Prize. Weekly Winners are still eligible to win the Grand Prize if all criteria are met.

Eligible Cards are First Financial issued Visa® credit cards. Eligible "Digital Wallet" purchases (which means the Apple, Google, Samsung, and Garmin digital wallet(s) to which an Eligible Card has been provisioned) and online purchases using an Eligible Card during the Sweepstakes Period will count towards the five (5) purchase transactions.

The following transactions are not eligible for entries into the Sweepstakes: cash advances, ATM transactions, credit vouchers, balance transfers, credit insurance premiums, debt cancellation program fees and other non-purchase transactions, as well as account fees per First Financial's Schedule of Fees, service charges or interest charges of any kind.

Mail-in Entries must be postmarked no later than July 29, 2026, and received by First Financial by the end of the Sweepstakes Period. Proof of mailing does not constitute proof of delivery. First Financial is not responsible for lost, late, incomplete, misdirected, damaged, postage-due or illegible entries or mail. Mechanically reproduced entries will not be accepted. Limit one Mail-In Entry per outer mailing envelope per person. Once submitted, all entries become the property of First Financial.

All entries must be received during the Sweepstakes Period by July 31, 2026, at 11:59 PM EDT. Limit one entry per person for the entire Sweepstakes Period. Any additional entries are void and will not be counted. Each entry has an equal chance of winning. First Financial will not verify receipt of entries. First Financial and its advertising and/or promotions agencies are not responsible for lost, late, illegible, misdirected or stolen entries or transmissions, or problems of any kind whether mechanical, human, or electronic.

Prize Details: First Financial will award two (2) prizes for three (3) weeks during the Sweepstakes Period and two (2) grand prizes at the conclusion of the giveaway based upon a random drawing of all eligible entries and the winner's acceptance of the prize as set forth below.

- Six (6) total weekly prizes; each prize valued as a \$100 baseball-themed gift basket from Black Eyed Susan Gift Baskets.
- Two (2) Grand Prizes; each prize valued as a \$250 MLB eGift Card or cash equivalent.

The gift basket will be shipped to the Winner's nearest First Financial branch or directly to the Winner's residential address on file.

Drawing and Awarding of Prize(s): Winners will be selected in a random drawing from among all eligible entries received. Weekly Drawings will take place on or about July 10, July 20 and July 31, 2026. Grand Prize Drawing will take place on or about August 3, 2026.

Drawing and awarding of the prize will be conducted by First Financial, whose decisions on all matters relating to this Sweepstakes are final. First Financial will attempt to notify the prize winner via e-mail, phone, and/or mail using the e-mail address, address, and phone number on file for the account associated with entry or included on the Mail-in Entry. Upon receiving notification of winning, the winner must complete, sign, and return the Statement of Eligibility, Waiver of Liability, and Publicity Release, except where prohibited by law, to First

Financial within five (5) business days of such notification.
